Pursuant to Article 75 of the State University of Novi Pazar Statute, the State University of Novi Pazar Senate at the session held on 21 February 2018, brings

# REGULATIONS OF METHODOLOGY OF ECTS POINTS ASSIGNMENT

#### Article 1

By these regulations, methodology of ECTS points assignment of **I**, **II**, and **III** study level at the State University of Novi Pazar is determined.

### Article 2

ECTS ("European Credit Transfer System") represents a numeric value by which the engagement of a student is valued, which is necessary for mastering:

- subject matter in total,
- all subject matters in total,
- academic year,
- studying in general.

#### Article 3

Bachelor academic studies contain 240 ECTS points and last 4 years.

Integrated studies contain 300 ECTS points and last 5 years.

Specialist academic studies contain 60 ECTS points, after previous graduation from graduate academic studies.

Master's academic studies contain 60 ECTS points, after previous graduation from bachelor academic studies which contain 240 ECTS points.

Doctoral studies contain 180 ECTS points, after previously achieved total in studying of at least 300 ECTS points accomplished at bachelor academic and graduate academic studies.

## Article 4

The complete engagement of the student consists of active teaching (lectures, exercises, practicums, seminars etc.), independent learning, mid-term exams, final exams, final paper writing, volunteering work in the local community and other kinds of engagement.

## Article 5

All forms of active teaching, including the final exam, make a whole. Points are achieved within the teaching activities provided for every subject matter, but are recognized only after student passes exam of the specific subject matter. Points that are acquired for the specific subjects enter into points total required for finishing each year i.e. specific study level.

# Article 6

Study program total performed during an academic year contains 60 ECTS points and responds to average total of student's engagement within the total of 40 working hours' week during an academic year.

### Article 7

Every subject is assigned with a number of ECTS points (in the following text: ECTS) so that the complete engagement of the student during an academic year is maximal 1800 working hours, i.e. 60 ECTS.

One ECTS point represents 30 hours of the complete student's engagement in all activities related to mastering the subject matter, including also all forms of testing.

One ECTS point is the equivalent to one ECTS credit point in the European system of point transfer.

Depending on complete engagement of the student within the subject (active teaching, seminary paper, graphic and other papers, consultations, time for preparing and passing exam), an appropriate number of ECTS points is uniquely assigned.

ECTS point number assigned to every subject is determined and adopted at the session of the Department Council.

ECTS point number is necessarily asserted in all relevant documents related to the teaching process at the University.
